



These terms and conditions apply to the schools and football clubs entering the prize draw.

1. The Promoter

The promoter is: Football Association of Wales Limited ("**FAW**") of The Pavilion, Vale Resort, Hensol, Vale of Glamorgan, CF72 8JY.

2. How to enter

- 2.1 The prize draw will run from [00:00] on [11/12/23] (the "**Opening Date**") to [23:59] on [31/12/23] (the "**Closing Date**") inclusive.
- 2.2 All prize draw entries must be received by the FAW in accordance with condition 2.3 by no later than [23:59] on the Closing Date. All prize draw entries received after the Closing Date are automatically disqualified.
- 2.3 To enter the prize draw, you must submit the prize draw online entry form by the 31st of December.
- 2.4 The winners will be notified via email during the week commencing the 8th of January.
- 2.5 The FAW will **not** accept:
 - (a) responsibility for prize draw entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - (b) transmission as proof of receipt of entry to the prize draw.
- 2.6 By submitting a prize draw entry, the entrant will be bound by these terms and conditions.

3. Eligibility

- 3.1 The prize draw is open to every member of The Red Wall based in the UK, **except**:
 - (a) employees of the FAW or its holding or subsidiary companies;
 - (b) employees of agents or suppliers of the FAW or its holding or subsidiary companies, who are professionally connected with the prize draw or its administration; or
 - (c) members of the immediate families or households of (a) and (b) above.
- 3.2 In entering the prize draw, the entrant is confirming that the entrant is eligible to do so and eligible to claim the prize.

- 3.4 The FAW reserves all rights to disqualify the entrant if their conduct is contrary to the spirit or intention of the prize.

There will be two runners up who will each receive a copy of EAFC24 and Football Manager 2024

- 4.2 Prizes are subject to availability. There is no cash alternative for the prize. The FAW has the right to change, alter or withdraw the prize draw or the prize at any time due to any change in any applicable law or any events outside the control of the FAW.
- 4.3 The prize is not negotiable or transferable. The prize cannot be resold. Any attempt to exchange or sell the prize will result in the prize being withdrawn by the FAW.
- 4.4 In order to claim the prize, you must look out for an email from the FAW and accept the prize within 48 hours of receiving it.

5. Winners

- 5.1 The winners will be selected at random the week commencing the 8th of January 2024. The decision of the FAW is final and no correspondence or discussion will be entered into.
- 5.2 The winners will be selected at random.



- 5.3 The FAW will notify the entrants of the winners personally as soon as practicable after the date referred to in condition 5.1, using the telephone number or email address provided with the prize draw entry.
- 5.4 The FAW must either publish or make available information that indicates that a valid award took place. To comply with this obligation the FAW may send the name of the entrants of prize winners to anyone who emails or writes to the address set out in Condition 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the prize draw.
- 5.5 If you object to any or all of your name and winning entry being made available, please contact the FAW [info@faw.cymru]. In such circumstances, the FAW must still provide the information and winning entry to the Advertising Standards Authority on request.

6. Claiming the prize

- 6.1 Winners will have 48 hours from the time at which the FAW notifies the entrant to claim the prize by verbally accepting the prize. If you do not claim the prize by this date, your claim will become invalid.
- 6.2 The prize may not be claimed by a third party on your behalf.
- 6.3 The FAW will make all reasonable efforts to contact the winner. If they cannot be contacted or is not available, or has not claimed the prize within 48 hours of the FAW's notification, the FAW reserves the right to offer the prize to the next eligible entrant selected from the entries that were received before the Closing Date.
- 6.4 The FAW does not accept any responsibility if you are not able to take up the prize.

7. Limitation of liability

Insofar as is permitted by law, the FAW, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the FAW, its agents or distributors or that of their employees. Your statutory rights are not affected.

8. Data protection and publicity

- 8.1 The FAW will only process your personal information as set out in the [privacy policy](#). See also condition 5.4 and condition 5.5, with regard to the announcement of winners.



9. General

- 9.1 If there is any reason to believe that there has been a breach of these terms and conditions, the FAW may, at its sole discretion, reserve the right to exclude you from participating in the prize draw.
- 9.2 The FAW reserves the right to hold void, suspend, cancel, or amend the prize draw where it becomes necessary to do so.
- 9.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
